



# Older adults service directory for GPs 2025

## Overview of services

Sir Charles Gairdner Osborne Park Health Care Group (SCGOPHCG) has a strong focus on supporting the care of older adults and provides a range of services to meet their needs in the community.

These include acute and non-acute services for older adults living at home and for those who live in residential aged care homes.

### Services for older adults living at home 65+ or 50+ if Aboriginal

#### Acute services – Only for those at high risk of acute admission

# RAILS Rapid Response Team SCGH, OPH catchment areas

RAILS is a **nursing** and **allied health** team providing a rapid response service for people over 65 years through home visits and phone consults. The team aims to make contact within 48 hours.

The program effectively prevents avoidable ED visits by supporting older adults within their home through provision of services, equipment and urgent nursing/allied health support.

#### Acute services – Only for those at high risk of acute admission

#### Frailty Rapid Access Clinic (FRAC) SCGH, OPH catchment areas

A multidisciplinary clinic for older adults at imminent risk of presenting to hospital with geriatric syndromes (eg: falls, pain, cognitive decline).

FRAC addresses the acute care needs and supports the patient to access ongoing health and community care as required.

#### For urgent reviews (7-10 days), refer directly via fax (08) 6457 8405.

Otherwise via CRS: Frailty Rapid Access Clinic. If unsure of suitability, contact the care navigator on 0491 369 932 (Mon-Fri, 8am-4pm).

#### **Non-acute services**

#### **Geriatric specialty clinics**

General, memory, falls, continence, fragile bone, Parkinson's.

#### Outpatient Allied Health Day Therapy Unit

(PT, OT, speech, dietetics, social work)

Refer via CRS.

Individual criteria apply.

#### **Outpatient allied health – catchment differs for each service**

Dietetics (OPH) 6017-6022, 6029, 6050 (Menora and Coolbinia only), 6059-6061, 6062 (Noranda only), 6066-6067, 6090.	For OPH - Referral form on OPH website > Our services > <u>Dietetics and Nutrition</u>
Dietetics (SCGH)	For SCGH – Only internal referrals from SCGH consultants. GPs may refer to relevant speciality clinic via CRS. Once accepted, the consultant can on-refer if tertiary dietetic support if indicated.

Podiatry (SCGH/OPH) (6017-6037, 6059-6061, 6064-6065 only)	Strict criteria apply. See SCGH/OPH website > Our Services > <u>Podiatry</u> for details.
Speech Pathology (OPH) 6017 – 6024, 6029, 6050 (Coolbinia and Menora only), 6059 – 6062, 6064, 6066 and 6090	Contact details on OPH website > Our Services > <u>Speech Pathology</u> . GP referrals required for outpatient services, except for Parkinson's Clinic which requires CRS referral.
Speech Pathology (SCGH)	Only internal referrals from SCGH consultants. GPs may refer to relevant specialty clinic via CRS. Once accepted, consultant can on-refer.
Social Work (OPH) (catchment variable based on clinic type)	See OPH website > Our Services > <u>Social Work</u> for details. GPs may refer to relevant specialty clinic, once accepted medically, can be on-referred to Social Work.
Social Work (SCGH)	Only internal referrals from SCGH consultants.



### Living in residential aged care homes

#### **Non-acute services**

#### **Residential Care Line (RCL)** All Perth metropolitan areas

RCL is a nurse practitioner-led service that supports staff and residents in aged care facilities to provide care in place and reduce the need for unnecessary ED presentations through phone consults and site visits.

The team provides timely access to appropriate care pathways to improve the quality of life of the older person living in residential care.

#### Geriatric Residential Outreach (GRO) SCGH, OPH & JHC catchment

GRO provides a visiting geriatrician review service at RACFs. Common referrals are increasing falls, cognitive or behavioural changes, Parkinson's disease, medication issues or recent unplanned hospitalisation.

Standard outpatient specialty geriatric services remain available for ambulant RACH residents.
